AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and Big Bear Coffee Roasting Company LLC (“**Company**”, “**we**”, “**us**”, or “**our**”), concerning your access to and use of the <https://www.bigbearcoffeeroastingcompany.com/> website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”). The number of arbitrators shall be _____. The seat, or legal place, of arbitration shall be _____. The language of the proceedings shall be _____. The governing law of the contract shall be the substantive law of _____.

Restrictions

The Parties agree that any arbitration shall be limited to the Dispute between the Parties individually. To the full extent permitted by law, (a) no arbitration shall be joined with any other proceeding; (b) there is no right or authority for any Dispute to be arbitrated on a class-action basis or to utilize class action procedures; and (c) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.
